Following are the terms of reference:

### **Proctor's Definition**

A proctor would be a faculty member preferably with three years of service and ready to work with the students. He/she is a decent person, a man or woman with principles, one who enjoys good reputation amongst colleagues and students and who also enjoys conversing with students. A proctor is a role model, a mentor and a guide for the students. Proctors will be governed by the Chief Proctor who will be a senior Professor/Dean. Position of proctor is honorary in nature.

#### **Proctor's Duties**

- Proctors will make sure that students are following the dress code
- Students' language on campus is proper
- Students are not involved in indecent activities like playing cards, watching unwanted movies on laptop etc.
- Students are behaving properly in the company of opposite sex
- Students are behaving properly in University functions organized by the University on campus and off campus
- Students are not unnecessarily loud in the corridors

#### Other related activities

Proctors individually, collectively or through University will arrange programs, which may improve students' personality, ethics and participation in community or social work on or off campus.

### Procedure of Work

In case a proctor finds a student in an unhealthy activity proctor will ask the student to refrain. In case student does not listen to the proctor or has already committed a mistake proctor may fine the student. This he can do by asking his/her registration number and forward it with recommendation of fine to Director Students Affairs. Director Students Affairs will facilitate proctors in processing the punishment.

### Role and Responsibilities of Proctors

Proctor is an honorary position and their role is parental and by demonstration they will also have the right to fine students for misbehavior. Chief Proctor with his team will work in close collaboration with Director Student Affairs. They will keep discipline of students on campus and can fine or suspend students if found guilty.
